## WQXA'S "DROPKICK MURPHYS ONLINE RTW TICKET GIVEAWAY - MARCH 7-9, 2025" CONTEST OFFICIAL RULES

The Station will conduct the WQXA's "Dropkick Murphys Online RTW Ticket Giveaway - March 7-9, 2025" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number.
